

**SUMMARY ANNUAL REPORT FOR
TOLEDO ELECTRICAL WELFARE FUND**

TO ALL PARTICIPANTS

This is a summary of the annual report for the Toledo Electrical Welfare Fund, I.D. #34-4441661 for the year beginning January 1, 2006 and ending December 31, 2006. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 [ERISA].

The Trustees have committed the Plan to pay benefits which include medical, prescription drug, disability, vision, death, accidental death and dismemberment, education reimbursement, employee retention, dental, hearing and supplemental fringe benefits under the terms of the Plan.

INSURANCE INFORMATION

The Plan also has contracts with (1) Gerber Life Insurance Co. for stop loss insurance for catastrophic medical claims (2) Fort Dearborn Life Insurance Company, and; (3) Vision Service Plan. Total premiums paid for the Plan year ending December 31, 2006 were \$381,648.

BASIC FINANCIAL STATEMENT

The value of the Plan assets, after subtracting liabilities of the Plan, was \$20,971,419 as of December 31, 2006, compared to \$11,603,752 as of December 31, 2005. During the Plan year, the Plan experienced an increase in its net assets of \$9,367,667. The Plan had a total income of \$30,714,566, including employer contributions of \$29,370,607, participants contributions of \$363,818, and earnings from investments of \$980,141.

Plan expenses were \$21,346,899. These expenses included \$1,111,780 in administrative expenses, and \$20,235,119 in benefits paid to or on behalf of Plan participants and beneficiaries.
